PROJECT DESCRIPTION

Work includes, but is not limited to:

- Surface cleaning and preparation of precast concrete, stucco, and red brick surfaces.
- Application of primers, sealers, and coatings in accordance with Master Painters Institute (MPI) standards.
- Repainting of hollow metal doors, frames, canopies, and bollards.
- Sealing of masonry and brick surfaces.
- Pressure washing and restriping of parking areas.
- Replacement and installation of exterior joint sealants.

BID REQUIREMENTS

Interested contractors must submit:

- 1. A completed Bid Form showing itemized pricing for each proposal section (A-G).
- 2. Proof of insurance (liability and workers compensation).
- 3. Three (3) references for comparable commercial or municipal projects completed within the past three years.
- 4. Copy of current city license, any applicable certifications and certificate of insurance.

PAINT SPECIFICATION

Project: Henry County Sheriff's Office

1. GENERAL REQUIREMENTS

All surface preparation and application shall comply with PCA Industry Standards and Master Painters Institute (MPI) specifications. Apply coatings in accordance with manufacturer's published data and MPI standards for each referenced system. All materials for each system shall bMPI-approved under the corresponding system number. Colors, sheens, and gloss levels shall be verified and approved before application. Protect adjacent finishes, fixtures, and surfaces during all coating operations.

2. SURFACE PREPARATION

Remove dirt, dust, grease, efflorescence, laitance, and contaminants. Remove loose or peeling coatings (SSPC-SP 2 Hand Tool Cleaning or SP 3 Power Tool Cleaning). Sand glossy surfaces to dull sheen. Mask and protect adjacent work. Pressure-wash all masonry, stucco, and concrete as indicated. Ensure surfaces are clean, dry, and sound prior to priming or coating.

3. WORK AREAS & MPI SYSTEMS

Proposal A – Hollow Metal Doors, Frames, Overhead Frames, Canopy & Bollards

Scope of Work:

- Sand all surfaces to receive paint.
- Apply rust-inhibitive primer to all ferrous metal.
- Apply finish coats to achieve a uniform, durable appearance.

System:

- Primer MPI # 134 Primer (Interior/Exterior, Metal)
- Finish MPI # 169 Exterior Latex Gloss or Semi-Gloss (Alkali-Resistant Acrylic for Metal Surfaces)
- Coats: 1 primer + 2 finish coats

Proposal B - Precast Concrete & Stucco (Pressure Wash Only)

Scope of Work:

- Pressure-wash all precast concrete and stucco surfaces to remove contaminants. No coating is required under this proposal.

Proposal C - Precast Concrete & Stucco (Sealer System)

Scope of Work:

- Apply clear - Apply clear water-repellent sealer.

to all precast and stucco surfaces.

System:

- Sealer - MPI # 34 Water Repellent for Concrete & Masonry - Clear

Proposal D – Precast Concrete & Stucco (Paint System)

Scope of Work:

- Apply masonry filler to precast surfaces.
- Apply masonry conditioner to stucco.
- Apply two (2) finish coats to stucco and precast, up to three colors. System:

- Conditioner MPI #3 Concrete & Masonry Primer/Sealer Pigmented
- Filler MPI #4 Elastomeric Block Filler
- Finish MPI #11 Exterior Latex Flat (Acrylic) or MPI #15 Exterior Latex Low Sheen/Satin
- Coats: 1 filler + 2 finish

Proposal E - Red Brick (Seal System)

Scope of Work:

- Pressure-wash red brick surfaces.
- Apply clear water-repellent sealer.

System:

- Sealer - MPI # 34 Water Repellent for Concrete & Masonry - Clear

Proposal F - Parking Lots

Scope of Work:

- F1: Pressure-wash front parking lot & sidewalks.
- F2: Pressure-wash back parking lot & sidewalks.
- F3: Re-stripe parking lines in front & back lots.

System:

- Cleaning only for F1 & F2.
- Pavement Marking Paint MPI #97 Traffic Marking Paint Yellow (Exterior Waterborne Acrylic)

Proposal G - Exterior Caulking

Scope of Work:

- Remove all existing failed sealant from control joints.
- Install new backer rod as needed.
- Apply polyurethane sealant to control joints.

System:

- Sealant ASTM C920 Type S or M, Grade NS, Class 35 Polyurethane Sealant
- Color: Gray

4. EXECUTION

Apply coatings under suitable environmental conditions (per MPI Glossary). Maintain required film thickness; do not thin coatings beyond MPI limits. Allow full dry time between coats. Each coat shall present an even, uniform appearance, free of runs, sags, or holidays. Remove masking and clean adjacent surfaces upon completion.

5. WARRANTY

Contractor shall provide a one-year workmanship warranty
